Your experience as a student:

MSW students are required to read textbooks and articles and to synthesize material from multiple sources into content for papers, presentations, and skills demonstrations. This is different from the level of preparation you needed to have as an undergraduate student.

- How will you ensure that you succeed academically in the MSW program?
- Name an academic challenge that you experienced and explain how you overcame it or what you would do differently in graduate school.
- If your overall undergraduate GPA is below a 3.0, please explain what happened and what you will do differently in graduate school.

Your time commitments:

The program is academically rigorous, emotionally challenging, and time consuming because we are preparing you to work with people who are depending on you to be an ethical, competent, culturally sensitive. and responsive social worker. You should plan to spend at least 3 hours per week on each course in addition to your other responsibilities. Courses in the in person, on campus MSW program are 15 weeks in length and meet for 150 minutes each week. You have the option of completing the program in 2, 3, or 4 years. Courses are offered in fall and spring with some elective options in the summer. Advanced standing students can complete the program in 1 year, with a summer start, or 2 years.

You will complete two practicum experiences during the program, almost all of them require you to be in person at a social service agency. You must have weekday availability for 15 hours across two-three days to complete your first practicum experience and 21 hours across three-four days to complete your second practicum experience. There are very few evening and weekend practicum placements.
